MEETING MINUTES

Monday, February 4, 2002

Invocation was given by Rob Windes.

MAYOR COMMENTS

Mayor Woodcock stated that the Governor of Illinois has asked that communities throughout the State of Illinois appoint representatives to work with state and local governments in volunteer and community services in order to help those in need to create a healthier society. Mayor Woodcock appointed Commissioner John Fearheiley as Chairman of Volunteerism and Community Service.

Mayor Woodcock called upon Commissioner John Fearheiley to introduce a distinguished guest to the Council Members and guests. Commissioner Fearheiley introduced Mr. Roger Eddy who will be running for the State Representative position for the 109th District. Mr. Eddy hails from Crawford County. Mr. Eddy thanked the members for allowing him the opportunity to introduce himself and took a moment to tell the Council about his background, family, education and training. After a brief discussion between Mr. Eddy and local television and radio representatives, Mayor Woodcock moved along to further business.

Mayor Woodcock addressed Resolution No. 483 and stated that the Resolution would recognize that Terry C. Kaid was employed by the City of Mt. Carmel as City Attorney from January of 1981 until November 30, 1992. After a brief discussion the Resolution was approved.

ADDITIONAL REPORTS

The afore mentioned date is recognized as a State holiday and asked that it be rescheduled for Tuesday, February 19, 2002.
