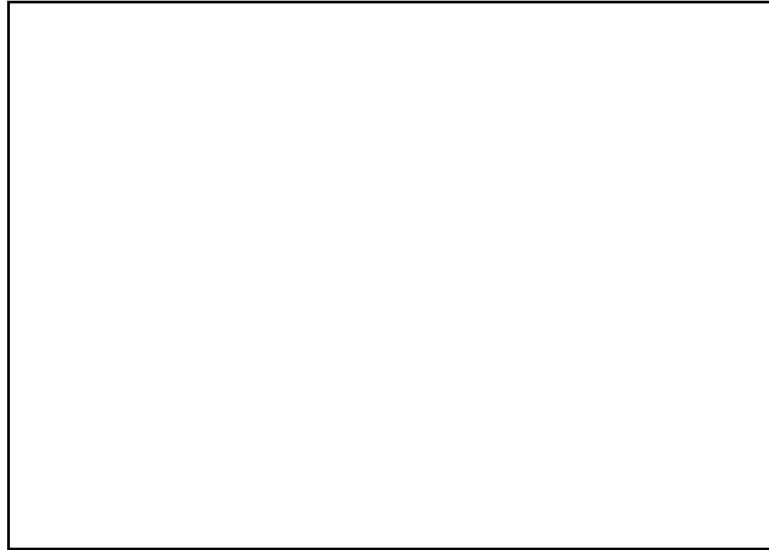

**ORDINANCE NO. 2099**

**ORDINANCE DEDICATING ROADWAY IN THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS**

**WHEREAS**, the City Council of the City of Mt. Carmel, Wabash County, Illinois, is the owner of a strip of land in Woodlawn Terrace Subdivision. Said strip of land as shown on a Plat recorded in Plat Cabinet 2, Slide 120, recorded February 22, 1983 in the office of the Recorder of Wabash County, Illinois; and

**WHEREAS**, said strip of land is intended to be used as a public road; and

**WHEREAS**, the City Council of the City of Mt. Carmel, Wabash County, Illinois, has determined that it is necessary and advisable to dedicate said strip of land as a public road

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS, as follows:**

1. That the City of Mt. Carmel is the owner of the following strip of land as shown on Plat recorded in Plat Cabinet 2, Slide 120, recorded February 22, 1983 in the office of the Recorder of Wabash County, Illinois.
2. That the surface of said strip of land shall be and is hereby dedicated by the City for public road purposes.
3. That henceforth said road shall be known as Easy Street.
4. That the City of Mt. Carmel shall retain ownership of said strip of land and all of the oil, gas, coal and other minerals thereunder.

This ordinance shall be printed in pamphlet form.
