ORDINANCE NO. 2091

AN ORDINANCE DIRECTING THE PLACEMENT OF STOP SIGN AT A CERTAIN INTERSECTION IN THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS

WHEREAS, the City of Mt. Carmel, Wabash County, Illinois has the authority pursuant to 625 ILCS 5/11-302 to designate certain intersections within its jurisdiction as stop intersections or yield intersections and to further erect stop signs or yield signs at those various intersections; and

WHEREAS, the City of Mt. Carmel, Illinois has investigated the existing traffic conditions and has determined that such intersection should be designated as stop intersection.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS, the following intersection shall be designated as stop intersections and stop sign shall be placed at the following location:

• Intersection of Lions Park Loop exit and Golf Cart Path from Number 1 tee box and Number 10 tee box – Stop sign at the exit of the park loop.

This ordinance shall be in full force and effect upon its passage and approval by the Mt. Carmel City Council, as provided by law.

This ordinance shall be printed in pamphlet form.
