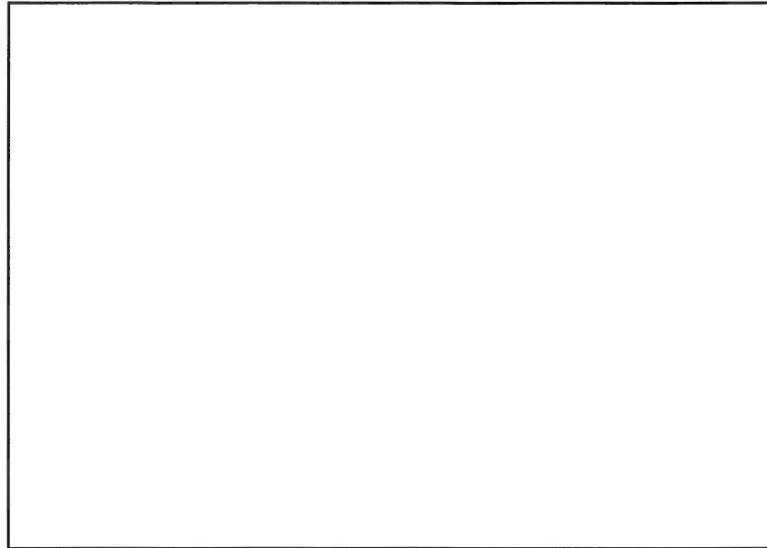

ORDINANCE NO. 2082

AN ORDINANCE DIRECTING THE PLACEMENT OF STOP SIGNS AT CERTAIN INTERSECTIONS IN THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS

WHEREAS, the City of Mt. Carmel, Wabash County, Illinois has the authority pursuant to 625 ILCS 5/11-302 to designate certain intersections within its jurisdiction as stop intersections or yield intersections and to further erect stop signs or yield signs at those various intersections; and

WHEREAS, the City of Mt. Carmel, Illinois has investigated the existing traffic conditions and has determined that such intersections should be designated as stop intersections; and

WHEREAS, the City Council of the City of Mt. Carmel, Illinois has approved by resolutions 660, 671, and 683 resolved that stop signs shall be placed at various locations.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS, the following intersections shall be designated as stop intersections and stop signs shall be placed at the following location:

- Intersection of 4th and Vine – Stop sign on North and South bound lanes of Vine Street,
- Intersection of 6th and Vine – Stop sign on East and West bound lanes of 6th Street,
- Intersection of 10th and Landes – Stop sign on East and West bound lanes of 10th Street,
- Intersection of 10th and Bainum – Stop sign on West bound lane of 10th Street,
- Intersection of 6th and Ash – Stop sign on North bound lane of Ash Street,
- Intersection of 4th and Plum – Stop sign on East bound lane of 4th Street,
- Intersection of 4th and Golden Aces Way – Stop sign on East and West bound lanes of 4th Street,
- Intersection of 6th and Plum – Stop sign on East and West bound lanes of 6th Street,

- Intersection of 6th and Pear – Stop sign on East and West bound lanes of 6th Street,
- Intersection of 7th and Pear – Stop sign on East and West bound lanes of 7th Street,
- Intersection of 7th and Plum – Stop sign on East and West bound lanes of 7th Street,
- Intersection of 8th and Pear – Stop sign on East and West bound lanes of 8th Street,
- Intersection of 11th and Pear – Stop sign on North bound lane of Pear Street,
- Intersection of 11th and Plum – Stop sign on North and South bound lanes of Plum Street,
- Intersection of Jaquess and Chestnut – Stop sign on West bound lane of Jaquess,
- Intersection of Sweeney and Bainum – Stop sign on North and South bound lanes on Sweeney,
- Intersection of 2nd and Pear – Stop sign on East bound lane of 2nd Street and a stop sign shall be removed from the north bound intersection on Pear Street.

This ordinance shall be in full force and effect upon its passage and approval by the Mt. Carmel City Council, as provided by law.

This ordinance shall be printed in pamphlet form.


I, Ryan Turner, certify that I am the duly appointed and acting City Clerk of the City of Mt. Carmel, Wabash County, Illinois.


