**ORDINANCE NO. 2081**

**AN ORDINANCE DIRECTING THE PLACEMENT OF NO PARKING SIGNS ALONG A STREET IN THE CITY OF  
MT. CARMEL, WABASH COUNTY, ILLINOIS**

WHEREAS, the City of Mt. Carmel, Wabash County, Illinois has the authority pursuant to 625 ILCS 5/11-1303 (a) 3.b. to designate certain streets within its jurisdiction as no parking and to further erect no parking signs on various streets; and

WHEREAS, the City of Mt. Carmel, Illinois has investigated the existing traffic conditions and has determined that a section of such street should be designated as no parking; and

WHEREAS, the City Council of the City of Mt. Carmel, Illinois has approved by resolution 681 passed on April 05, 2021 resolved that on the East side of Ash Street from 4<sup>th</sup> Street toward 5<sup>th</sup> Street to the intersection of Ash Street with the alley that runs East/West and Parallel to 4<sup>th</sup> Street be designated as no parking and that no parking signs shall be placed at this location.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS, the following section of street shall be designated as no parking and no parking signs shall be placed at the following location:

- On the East side of Ash Street from 4<sup>th</sup> Street toward 5<sup>th</sup> Street to the intersection of Ash Street with the alley that runs East/West and Parallel to 4<sup>th</sup> Street.

This ordinance shall be in full force and effect upon its passage and approval by the Mt. Carmel City Council, as provided by law.

This ordinance shall be printed in pamphlet form.


