## ORDINANCE NO. 56

AN ORDINANCE OF THE CITY OF MOUNT CARMEL, IN THE COUNTY OF WABASH, IN THE STATE OF ILLINOIS, MAKING THE ANNUAL APPROPRIATION FOR SAID CITY FOR THE FISCAL YEAR ENDING APRIL 30, 1956.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MOUNT CARMEL, ILLINOIS:

Section 1. That there be and is hereby appropriated by the City of Mount Carmel, in the County of Wabash and State of Illinois, out of its revenues accruing during the fiscal year beginning May 1, 1955, and ending April 30, 1956, other than revenues derived from water rentals, supervised recreation center tax, garbage disposal tax, library tax and parking meter collections, for the purpose of defraying all necessary expenses and liabilities and for general corporate purposes of said City, except for its water works system, supervised recreation center, garbage disposal system, public library and parking meter costs, maintenance and paving of park-ways, for the fiscal year beginning May 1, 1955, and ending April 30, 1956, the sum of Seventy-five Thousand Seven Hundred Eighty-five Dollars (\$75,785.00), of which said amount the sum of Thirty-one Thousand Five Hundred Dollars (\$31,500.00) shall be levied by said City hereafter as a general tax against all of the taxable property within the corporate limits of said City of Mount Carmel for the year 1955. The remainder of said appropriation not realized from taxes shall be paid out of other income for general corporate purposes derived by said City.

That said sum of Seventy-five Thousand Seven Hundred Eighty-five Dollars (\$75,785.00) so appropriated by this section of this ordinance be, and the same is hereby, set apart and appropriated and the portion above-mentioned shall be levied for the following specified objects and purposes:

Section 2. That there be and is hereby appropriated the sum of Eight Thousand Four Hundred Sixty-five Dollars (\$8,465.00) out of revenue arising and to be derived from the additional tax to be levied on all taxable property in the City of Mount Carmel, according to the valuation of the same, as made for the purpose of State and County taxation, for the year 1955 in said City, for the purpose of defraying the cost of collecting and disposing of garbage under its system for collecting and disposing of garbage in said City for the fiscal year beginning May 1, 1955, and ending April 30, 1956, which tax shall be in addition to the amount authorized to be levied for general corporate purposes as provided in Section 16-1 of the Revised Cities and Villages Act, approved August 15, 1941, and all amendments thereto.

Section 2 A. That there be and is hereby appropriated the sum of Five Thousand Five Hundred Dollars (\$5,500.00) for the purpose of defraying the cost of collecting and disposing of ashes and rubbish in said City and shall be derived from the special assessment provided in and by the ordinances of the said City of Mount Carmel.

Section 3. That there be and is hereby appropriated the sum of Sixty-four Thousand Dollars (\$64,000.00) for the operation and maintenance of the Water Works System owned and operated by said City out of the revenues arising from the water rentals derived from the operation of said system during the fiscal year beginning May 1, 1955, and ending April 30, 1956, in the amounts for purposes as follows:

That there be and is hereby appropriated the sum of Twenty-eight Thousand Seven Hundred Thirty-five Dollars (\$28,735.00) for the purpose of improving, adding to, maintaining and operating the supervised recreation center of said City of Mount Carmel as heretofore established for the fiscal year beginning May 1, 1955, and ending April 30, 1956, which said appropriation is for the following items and purposes:
