

**ORDINANCE NO. 2088**

**AN ORDINANCE APPROVING A SPECIAL USE FOR THE PLACEMENT OF A MOBILE HOME IN A R-3 RESIDENTIAL DISTRICT IN THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS**

WHEREAS, Jamie Linson desire to purchase the property at 518 ½ Poplar Street. Such purchase requires approval of a special use for the mobile home to remain on the property and used as their dwelling; and

WHEREAS, proper notice was given to all interested parties of such proposed special use; and

WHEREAS, the Zoning Board of the City of Mt. Carmel, Wabash County, Illinois has by its voting members unanimously recommended approval of Special Use 2023-SU-01 for Jamie Linson to allow the mobile home to remain on the property to be used as a dwelling;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MT. CARMEL, WABASH OUNTY, ILLINOIS,

That special use 2023-SU-01 is granted to the applicant Jamie Linson and is not transferable or assignable.

The description of the real estate covered hereby is as follows:

Sublot 13 Outlot 88, commonly known as 518 ½ Poplar Street.

PIN # 05-211-20-388-015 in the City of Mt. Carmel, Wabash County, Illinois.

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.
