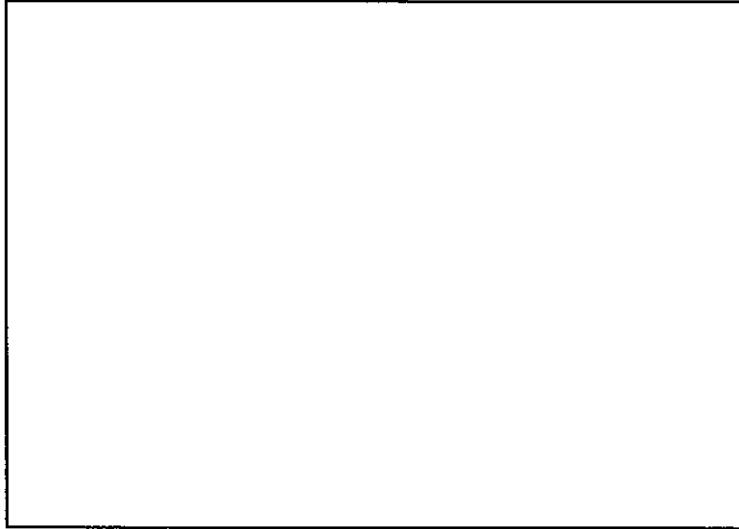

ORDINANCE NO. 2085

**AN ORDINANCE DIRECTING THE PLACEMENT OF NO PARKING SIGNS ALONG A STREET IN THE CITY OF
MT. CARMEL, WABASH COUNTY, ILLINOIS**

WHEREAS, the City of Mt. Carmel, Wabash County, Illinois has the authority pursuant to 625 ILCS 5/11-1303 (a) 3.b. to designate certain streets within its jurisdiction as no parking and to further erect no parking signs on various streets; and

WHEREAS, the City of Mt. Carmel, Illinois has investigated the existing traffic conditions on the East and West side of Cedar Street from 1st Street to 2nd Street and has determined that section of such street should be designated as no parking and that no parking signs shall be placed at this location.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS, the following section of street shall be designated as no parking and no parking signs shall be placed at the following location:


- On the East and West side of Cedar Street from 1st Street to 2nd Street.

This ordinance shall be in full force and effect upon its passage and approval by the Mt. Carmel City Council, as provided by law.

This ordinance shall be printed in pamphlet form.




I, Ryan Turner, certify that I am the duly appointed and acting City Clerk of the City of Mt. Carmel, Wabash County, Illinois.
